# Labor Day Parade Formation And Line Of March Announced; Big Boxing and Wrestling Card

Formation and line of march for the gigantic Labor Day parade in Princeton on Monday mornin, Sept. 6 were announced Friday.

The parade divisions will form on various streets in the south part of the city east and west of Main street. The head of the parade will move on Main street promptly at 10 o'clock and the various delegations, under the assistant parade marshal, will move out of the respective intersecting streets into the line. The entire space on all streets from Clark south to Kentucky has been set aside for the parade divisions.

## Line of March

The line of march will be headed by the Petersburg band. The parade will move north on Main to Broadway, west on Broadway to Hart, north on Hart to State, east on State to Main, north on Main to Spruce, West on Spruce to the north gate of the fairgrounds. On entering the fairgrounds, the long line will move entirely around the race track, so that judges in the judges stand may select winners for the several prizes offered for business men's and union men's parade representation. In this way, likewise, throngs of spectators may view the parade from the amphitheater.

## LEAGUE COUNCIL INVITED U. S. TO JANUARY MEETING

### FIRST OPPORTUNITY TO PARTICIPATE IN DELIBERATIONS — ARMS QUESTION IN CONFERENCES

GENEVA, Aug. 31 —(UP)— The United States was given its first opportunity today to participate with the Council of the League of Nations in the performance of its official functions.

On the proposal of W. L. Mackenzie Premier of Canada, the Council authorized Sir Eric Drummond, Secretary-General, to invite the United States to send representatives to the January session of the Council. The purpose would be to participate in the work of the new central board created by the League's 1925 opium convention for the control of the international traffic in drugs.

A new move in the disarmament controversy appeared likely today after two days conferences between Paul Boncour and Lord Cushendun.

It was considered highly probable that an attempt would be made to convolve the preparatory disarmament commission immediately after the forthcoming session of the League of Nations assembly which opens Monday.

In the event that convocation is possible, the preparatory commission will meet probably late in November or the early part of December.

## TRAIN ATTACKED AND ROBBED WITH SEVERAL KILLED

MEXICO CITY, Aug. 31 —(UP)— Seventy five bandits attacked and looted a coast-to-coast train between Cuantla and Puente Delxtla, State of Morelos, a dispatch said today.

All but one soldier of the train's military escort was killed, the message said.

## LEAGUE REFUSES TO INTERPRET MONROE DOCTRINE

GENEVA, Aug. 31 —(UP)— The League of Nations will refuse to interpret the Monroe Doctrine, it was understood on good authority today.

The League Council was reported to have drafted a reply at a secret meeting today to Costa Rica's demand for an interpretation of the Doctrine's application. The reply indicates that it is impossible for the Council to comply with the request because the Monroe Doctrine concerns only the States directly interested.
